NH DHHS Weekly COVID-19 Update – Week of December 8, 2022

Concord, NH – On Thursday, December 8, 2022, the New Hampshire Department of Health and Human Services (DHHS) announced 1,291 new positive COVID-19 test results between Thursday, December 1 and Wednesday, December 7.

For the previous week, DHHS announce 7 additional deaths related to COVID-19. We offer our sympathies to the family and friends.

There are currently 20 hospitalized patients being treated for COVID-19. In New Hampshire, since the start of the pandemic, there have been a total of 362,824 cases of COVID-19 diagnosed.
